The Lee County Board of Commissioners met in a voting session on Tuesday, October 25, 2022. The meeting was held in the Opal Cannon Auditorium of the Lee County T. Page Tharp Governmental Building in Leesburg, Georgia. Those present were Chairman Billy Mathis, Commissioner Luke Singletary, and Commissioner George Walls. Staff in attendance was County Manager Christi Dockery, County Attorney Jimmy Skipper, and County Clerk Kaitlyn Sawyer. Vice-Chairman John Wheaton was absent. The meeting was also streamed on Facebook Live. Chairman Mathis called the meeting to order at 6:00pm.

#### **Board of Elections and Registration**

#### (A) Consideration to approve the purchase of new equipment.

Director of Elections and Registration Veronica Johnson presented on the equipment in question, Georgia Poll Pad Printer Check-In Stations from KNOWiNK, LLC. Ms. Johnson stated that the Lee County Elections Office had been approached earlier in the year by the Secretary of State's Office to begin beta testing the equipment (the "Poll Pad"), and has been doing so for the current ongoing advance in-person voting. This equipment provides the capability to maintain an electronic voting list. In previous elections, while a voter's signature was captured digitally, there was no other verifiable paper audit trail; but, this equipment is attached to a printer and provides an application containing voter information. This new equipment would allow one more opportunity to show citizens how transparent and accurate all processes in Lee County elections are.

Ms. Johnson summarized the function of the equipment, stating that when a citizen arrives to vote, they scan their government issued ID, their record is presented, they can sign, and an application/receipt prints out. Said application is retained in the Elections office for two (2) years. The voter is then presented with a card and may proceed to a voting machine. Notable benefits to using the system include a faster check in experience, now having a verifiable paper audit trail, and the fact that all information communicates back to hub at the Elections Office, allowing staff to monitor voter check-in statistics at all voting precincts.

In the past week of utilizing the new equipment, the Elections staff as well as the voters have voiced that they liked using the new Poll Pads. Last night (October 24, 2022), a representative of the Secretary of State's Office had contacted Ms. Johnson stating that the beta testing was going well and inquired if this office would like to purchase the equipment and have it fully in place for Election Day on November 8. Ms. Johnson stated that the rest of the state probably will not have the opportunity to purchase this equipment until early 2023.

The application/ receipt contains the date, time, type of ID presented, and signatures of both the citizen and the Elections employee that processed the check in. This printout only contains information pertinent to the check in process and does not include anything about the person's ballot. A person's ballot is private and confidential.

Commissioner Singletary made the **MOTION** to <u>approve</u> the purchase of Georgia Poll Pad Printer Check-In Stations from KNOWiNK, LLC. at a cost of \$32,895.00, to be split into three equal annual payments of \$10,965.00, to come from <u>the General Fund</u>. Commissioner Walls seconded the **MOTION**. The **MOTION** was unanimous with Chairman Mathis voting yea.

#### **COUNTY MANAGER'S MATTERS**

County Manager Christi Dockery discussed ongoing projects in the County: (1) the CDBG project at Palmyra Mobile Home Park is moving forward as we are awaiting completed deeds and other paperwork to be finalized; (2) the Landfill Wall Phase II project is ongoing with an estimated completion of four to five weeks; and (3) the renovation of the gym is also ongoing.

#### (B) Consideration to award the bid for LED light fixtures in the fire stations.

Commissioner Singletary made the **MOTION** to <u>reject</u> the provided bids for LED light fixtures in the fire stations project, asking that staff <u>review</u> the Invitation to Bid documents and <u>reopen</u> the bid process at a later date. Commissioner Walls seconded the **MOTION**. The **MOTION** was unanimous with Chairman Mathis voting yea.

This Capital Improvements Element Annual Update has been prepared based on the rules and regulations pertaining to impact fees in Georgia, as specified by the Development Impact Fee Act (DIFA) and the Department of Community Affairs (DCA) documents Development Impact Fee Compliance Requirements and Standards and Procedures for Local Comprehensive Planning. These three documents dictate the essential elements of an Annual Update, specifically the inclusion of a financial report and a schedule of improvements.

#### Financial Report

The Financial Report included in this document is based on the requirements of DIFA, specifically:

"As part of its annual audit process, a municipality or county shall prepare an annual report describing the amount of any development impact fees collected, encumbered, and used during the preceding year by category of public facility and service area."

(O.C.G.A. 36-71-8(c))

The required financial information for each public facility category appears in the main financial table (page 2); each of the public facility categories has a single, county-wide service area. The status of all impact fee projects, by public facility category, is shown on the tables on pages 3, 4 and 5.

The County's fiscal year runs from July 1 to June 30.

#### Schedule of Improvements

In addition to the financial report, the County has prepared a five-year schedule of improvements—a community work program (CWP)—as specified in DCA's Compliance Requirements (Chapter 110-12-2-.03(2)(c)), which states that local

governments that have a CIE must "update their entire Short Term [i.e., Community] Work Programs annually.")<sup>1</sup>

According to DCA's requirements<sup>2</sup>, the CWP must include:

- A brief description of the activity;
- Legal authorization, if applicable;
- Timeframe for undertaking the activity;
- Responsible party for implementing the activity;
- Estimated cost (if any) of implementing the activity; and,
- Funding source(s), if applicable.

All of this information appears in the Community Work Program portion of this document, beginning on page 6.

Note that DCA's Compliance Requirements specify that the work program is to meet the requirements of Chapter 110-12-1-.04(7)(a), which is a reference to the work program requirements in a previous version of the Standards and Procedures for Local Comprehensive Planning. The correct current description is found at Chapter 110-12-1-.04(2)(b)1.

At the July 12, 2022 Board of Commissioners meeting, Mrs. Trish Batten addressed the Board regarding the observance of the Juneteenth holiday. While Juneteenth is a Federal holiday, the Lee County Board of Commissioners nor the City of Leesburg currently observe it. Lee County personnel policies include 10 holidays that the County currently observes, all being federal holidays except Good Friday and the day after Thanksgiving.

Staff sent out an email asking cities and counties in the state of Georgia how many holidays they currently observe, and how many observe Juneteenth specifically. We received responses from 45 cities and counties, of which 15 do not observe Juneteenth. For the Counties that do, they observe anywhere from 11 to 15 holidays a year.

It is staff's recommendation that the Board of Commissioners vote to amend the personnel policy and add an additional holiday for a total of 11 observed holidays for County employees. The cost associated with this would be approximately \$38,648.00. This also seems to be what the majority of other Cities and Counties have done.

#### ARTICLE XVI HOLIDAYS

#### Section 16.01 Policy

For all regular full-time employees, a "Holiday" is defined by this policy as eight (8) hours in length.

#### Section 16.02 Application

This policy shall apply to all full-time employees who are subject to these policies.

#### Section 16.03 Provisions

#### A. Holidays Observed:

The general schedule of holidays is as follows.

New Year's Day
Martin Luther King, Jr.'s Birthday
Good Friday
Memorial Day
Independence Day
Labor Day
Thanksgiving Day and the day after Thanksgiving
Christmas Eve (unless designated otherwise by the Board of Commissioners)
Christmas Day

- 1. If a holiday falls on Sunday, it will be observed on the Monday following the holiday. If the holiday falls on a Saturday, it will be observed the Friday before the holiday.
- B. Eligibility for Holiday Pay:
  - 1. Only regular full-time employees are eligible for holiday pay.
  - 2. An employee who takes unauthorized leave on either the day before or the day after the holiday will not receive holiday pay and will be subject to disciplinary action.

#### C. Holidays Worked

An employee required to work on a holiday shall be given a compensated day off, at a later time, if the County's staffing needs permit, or receive additional pay at his or her hourly rate for time worked. However, if the compensated day off is not available due to the County's staffing needs, the employee will receive the additional pay in lieu of the compensated day off.

#### Section 16.04 Responsibility

Department heads are responsible for completing a report stipulating the employees who worked holidays and who are eligible to be paid overtime. If a department head is in doubt as to an employee's eligibility for overtime for holidays worked, the County Administrator should be contacted for guidance.

#### RESOLUTION REQUESTING SALES TAX INFORMATION FROM THE GEORGIA DEPARTMENT OF REVENUE PURSUANT TO O.C.G.A. §48-2-15(d.1) AND NAMING A DESIGNATED OFFICER FOR ALL RELATED PURPOSES

WHEREAS, Georgia Code (O.C.G.A.) §48-2-15, as amended in 2018, authorizes the Commissioner of the Georgia Department of Revenue (hereinafter the "DOR Commissioner") to provide certain confidential sales tax information to the "designated finance officer or taxing official" of counties and other local governments; and

WHEREAS, more specifically, O.C.G.A. §48-2-15(d.1) authorizes the DOR Commissioner to provide to a local government's designated officer, upon request, certain information relating to vendors that have submitted sales tax reports within the period of time set forth in that request; and

WHEREAS, O.C.G.A. §48-2-15(d.1) further allows the local government's designated officer to request that the DOR Commissioner validate, from time to time, the political subdivision to which sales taxes are being remitted by taxpayers with a business location within that local government's boundaries; and

WHEREAS, Lee County desires to obtain the sales tax information described in the above Georgia Code Section;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of Lee County, as follows:

1. The Board of Commissioners hereby designates the following finance or tax official as Lee County's Designated Officer for all purposes described in O.C.G.A. §48-2-15(d.1):

- 2. The Board of Commissioners hereby requests that the DOR Commissioner (or his/her designee) furnish to the above-named Designated Officer all vendor sales tax information described in O.C.G.A. §48-2-15(d.1)(1) for Lee County for the following time period: One year, beginning 11/10/2022.
- 3. In accordance with O.C.G.A. §48-2-15(d.1)(2)(B) and following receipt of the information described in Paragraph 2, above, the Designated Officer is hereby authorized to request validation by the DOR Commissioner of the political subdivision to which one or more vendors/taxpayers with a business location in Lee County have remitted sales taxes for the designated period, with such validation request to contain the business name and location address of each such

- vendor/taxpayer and such other information as may assist the DOR Commissioner in responding to such validation request;
- 4. The Designated Officer shall use such information only in the discharge of his/her duties and shall maintain the confidentiality of such information as required by O.C.G.A. §48-2-15(d.1); and
- 5. The Board of Commissioners shall comply with all confidentiality requirements of O.C.G.A. §48-2-15(d.1), including, but not limited to, the requirements that 1) such information may only be discussed by members of the Board of Commissioners in executive session and 2) members of the Board of Commissioners shall recuse themselves from such executive session discussions in the event of a conflict of interest as described in the above Georgia Code Section.

**BE IT FURTHER RESOLVED,** that this Resolution shall become effective upon its approval by the Lee County Board of Commissioners, and the official named above shall remain Lee County's Designated Officer for all purposes under O.C.G.A. §48-2-15(d.1) until further action of the Board of Commissioners.

**BE IT FURTHER RESOLVED,** that the Lee County Clerk is hereby directed to provide a certified copy of this Resolution to the Georgia Department of Revenue via email (<a href="mailto:public.disclosure@dor.ga.gov">public.disclosure@dor.ga.gov</a>) or to otherwise transmit a copy of this Resolution as may directed by the Georgia Department of Revenue.

#### ARTICLE V. - R-1 SINGLE-FAMILY RESIDENTIAL DISTRICT

#### Sec. 70-161. - Statement of purpose.

This district is composed of certain areas having a single-family residential character and undeveloped land where it is desirable and likely that similar development will occur. This district will be characterized by medium density residential development. The specific purpose of this district is to:

- (1) Encourage the construction and continued use of the land for single-family dwellings;
- (2) Prohibit business, commercial or industrial use of the land, and to prohibit any other use which would substantially interfere with development or maintenance of singlefamily dwellings in the district;
- (3) Encourage the discontinuance of existing uses that would not be permitted as new uses under the provisions of these regulations;
- (4) Discourage any land use that would generate traffic on minor or local streets, other than normal traffic to serve residences on those streets;
- (5) Discourage any use which, because of its size or character would create requirements and costs for public services such as fire and police protection, water supply and sewerage substantially in excess of such requirements and costs if the district were developed solely for residential purposes.

(Ord. of 12-2-2002, § 70-161)

#### Sec. 70-162. - Permitted uses.

- (a) Single-family, detached dwellings, except for manufactured or mobile homes.
- (b) Zero lot-line housing if shown on an approved subdivision plat.
- (c) Accessory buildings or uses customarily incidental to any of the permitted uses, when located on the same lot as the primary dwelling and not involving any business, profession, trade or occupation, provided that all accessory buildings shall conform and be located as required in section 70-84 of this chapter.

#### Sec. 58-86. Approval of minor subdivisions.

- (a) An applicant requesting approval of a proposed minor subdivision shall submit to the planning department ten copies of the plat and legal description, or such other number as the planning director deems necessary, together with a completed application form and the stipulated fee. The plat shall conform to the following requirements:
  - (1) All minor subdivision plats shall meet the land development and road and drainage standards of the county as outlined in chapter 70, chapter 38, and this chapter.
  - (2) The minor subdivision plat shall be at a scale no smaller than 200 feet to the inch, unless otherwise approved by the county planner, and prepared by a land surveyor registered in the state.
  - (3) The minor subdivision plat shall be drawn in ink or by computer printer on sheets no larger than 18 inches by 24 inches unless otherwise approved by the planning director.
  - (4) The minor subdivision plat and accompanying documentation shall show all existing conditions and shall show all proposals, including the following:
    - a. Proposed subdivision name or identifying title.
    - b. Name of owner of tract or his authorized agent, if any, and the signature and declaration of ownership of the owner.
    - c. The names of all owners of all adjacent unplatted land.
    - d. Reference to recorded subdivision plats of adjoining platted land by record names and date.
    - e. Vicinity map at a scale of not less than one inch equals one mile showing the relationship of the proposed subdivision to surrounding development. The scale of the vicinity map should be shown as well as the north arrow of the vicinity map.
    - f. Names and right-of-way width of all roads and other rights-of-way; and similar data for alleys, if any.
    - Location, dimensions and purpose of easements.
    - h. Lot lines, lot numbers (consecutively numbered), lot sizes (to the nearest thousandth of an acre), and the area in parks, etc.
    - If requested by the planning staff, topographic maps of all land subdivided the scale and contour interval to be determined by the planning staff (separate map from recording plat).
    - j. Minimum building setback lines of all residential lots and all other lots smaller than five acres.
    - k. Numerical scale, graphic scale, north arrow, and date of plat.
    - I. All elevations based on sea level datum.
    - m. Pertinent soil data, if required by the county health department where the subdivision is not to be served by the community sewerage system. (Separate map from recording plat.)
    - Legal description of the platted area.
    - o. Primary control points and benchmarks with necessary descriptions and locations of such control points, including all dimensions, angles, bearing and similar data necessary for proper location.
    - p. Accurate dimensions, bearings or deflection angles, radii and area and central angle of all curves of all lots, tracts, right-of-way lines of streets, easements or other right-of-way.
    - Purpose for which sites, other than residential lots, are dedicated or reserved.

- r. Location and description of monuments.
- Reference to recorded subdivision plats of adjoining platted land by record names, date and number.
- t. Certification by a land surveyor registered in the state to the accuracy of the survey and minor subdivision plat.
- The location of all areas within the 100-year floodplain as determined by the manager of development services.
- v. Acreage of total area to be subdivided.
- (5) The minor subdivision plat shall be submitted in paper and one copy to be in digital form with the .dxf the preferred digital format though DRG and DWG will be accepted.
- (b) Review and actions for a minor subdivision may be handled administratively by the planning director or his designee after review of the full staff. Within 14 days of certification that the application is complete, or within such further time as consented to by the developer, the planning director or his designee will either approve, deny, request changes in the plat that are necessary for approval, or request that the developer submit the subdivision application to the planning commission for review and action, either approval or denial, at their next regularly scheduled meeting.
- (c) After the application has been approved through action or inaction by the planning director or his designee or the planning commission, the planning director or his designee shall affix an appropriate stamp and signature to such approved plat and inform the developer in writing that the plat is ready for recording.
- (d) Actions of the planning director may be appealed to the board of commissioners at their next regularly scheduled meeting.
- (e) If a minor subdivision involves the conveyance of a property or easements to the county, the following items shall be required:
  - (1) Title opinion
  - (2) Warranty deed conveying the property.
  - (3) Quitclaim deed (if applicable).
