## PET ADOPTION AGREEMENT

IN CONSIDERATION of the mutual promises and agreements hereinafter set forth, and other good and valuable consideration the sufficiency and receipt of which acknowledged, the parties hereto do mutually promise, covenant, and agree as follows:

The adopter hereby promises, covenants, and agrees that he/she adopts \_\_\_\_\_ from the Lee County Animal Shelter to be a companion for my immediate family and/or myself.

I further promise, covenant, and agree to maintain annual vaccinations (or as needed) and any other medical treatment required by this adopted pet. I further promise, covenant, and agree that any animal that is adopted from Lee County Animal Shelter will be spayed or neutered by a county authorized veterinarian upon adoption. The shelter staff will make the appointment for foster animals that have reached the required weight. I understand that it is the owner's responsibility to make sure this appointment is kept, and that the information will be faxed to Lee County Animal Shelter. I further understand that if the owner does not comply, Lee County Animal Shelter will confiscate the animal and NO money will be refunded.

I further promise, convey, and agree to abide by city, county, and state animal control ordinances and statues regarding animal care, inoculations, custody, control, and humane treatment of this adopted pet. If at any time it becomes a hardship and I am unable to care for or keep the pet/animal, I promise to return the pet/animal to Lee County Animal Shelter so that they can find the pet/animal another home.

I further promise, covenant, and agree that the Lee County Animal Shelter and its agents do not guarantee the health of any animal at adoption time or thereafter. However, should a veterinary doctor find the adopted animal to be unhealthy within 30 days of adoption, I promise, covenant, and agree to return the animal to the Lee County Animal Shelter. I understand no money will be refunded to me. If the sick animal is returned within the 30-day period due to illness, I understand I may have the opportunity to pick another dog/cat for the same price or pay the difference.

I further agree that failure to comply with any of the promises aforementioned to the satisfaction of the Lee County Animal Shelter will void this agreement and agree if this agreement is void, I must return the pet/animal to the Lee County Animal Shelter and an Eighty-dollar (\$80.00) fee for canines and Thirty-dollar (\$30.00) fee for Felines will be due at that time. I further promise, covenant, and agree to hold the Lee County Animal Shelter and its agents harmless and free of any liability as a result of this adoption. This agreement contains the sole and entire agreement between the parties relating to the subject hereof; and any representation, promise or condition not contained herein, shall not be binding on either party. This agreement shall be governed and construed in accordance with the laws of the State of Georgia.
